3. DESCRIPTION OF MATERIAL CHANGE

Subsequent to CinemaONE's SME IPO Listing in November 2018, the Company initiated discussions with various financiers to secure debt financing in accordance with the Company's theatre expansion strategy as outlined in its approved IPO Prospectus. After evaluating competitive offers, CinemaONE's Board of Directors approved in its July 2019 meeting the execution of a term sheet from Guardian Group Trust Limited (GGTL).

GGTL's creative structuring has facilitated a longer 15 year loan tenor, in line with the Company's 15 and 20 year long term leases. Most importantly, the new \$40,000,000 loan facility will allow for the completion of CinemaONE's second multiplex site which is currently in development at Gulf City Mall, San Fernando. With the final closing of the Loan Agreement and settlement of loan proceeds on November 15, 2019, GGTL replaces CIBC as CinemaONE's primary, secured lender.
