<p>Trinidad and Tobago NGL Limited (“TTNGL”) hereby advises that at an Annual Meeting of the Shareholders held on March 5, 2026, the shareholders approved a special resolution authorizing the reduction of TTNGL’s stated capital account for all classes of shares proportionally, in the amount of TT\$2.2 billion.</p> <p>The reduction of stated capital does not affect the number of issued shares of TTNGL but reduces the amount standing to the credit of the stated capital account.</p> <p>The reduction enables TTNGL to satisfy the requirements under Section 54 of the Companies Act, Chap. 81:01 and facilitates the declaration and payment of dividends pursuant to Section 55 of the Companies Act.</p>


