### Provide a description of the material change

Further to a Material Change Report dated April 26th, 2021, wherein it was indicated, inter alia, that a Share Purchase Agreement (SPA) between Rosco Petroavance Limited, a subsidiary of Agostini's Limited and the Shareholders of Process Components Limited would be signed on or before July 31st, 2021 (or such further date as may be extended by mutual agreement of the Parties in writing, from time to time), the Parties determined that a Business Combination Agreement (BCA) instead of an SPA would be entered into and this BCA was executed on September 28th, 2021. Consequently, it is anticipated that Process Components Limited would be amalgamated with Rosco Petroavance Limited effective October 1st, 2021, thereby completing the acquisition of Process Components Limited.


