Reference is made to Material Change Report filed on April 27th, 2021wherein Agostini's Limited advised that on April 26th, 2021, Agostini's Limited and its subsidiary, Rosco Petroavance Limited executed a Letter of Intent with the Shareholders of Process Components Limited (the Company) for the purchase of 100% of the issued and outstanding shares in the Company subject to the successful completion of a due diligence, regulatory approval from the Fair Trade Commission and the satisfaction of conditions precedent outlined in a Share Purchase Agreement (SPA) to be executed between the Parties on or before July 31st, 2021 (or such further date as may be extended by mutual agreement of the Parties in writing, from time to time). In the aforementioned Report filed, a request for an exemption from publication was made at least until the signing of the SPA.
