FINANCIAL RESEARCH OFFICER IN THE DISCLOSURE REGISTRATION AND CORPORATE FINANCE DIVISION

A. Job Summary

The incumbent is required to evaluate the applications for the registration of all actors to be licensed under the Securities Act, 2012, review financial statements and other disclosure documents and provide research support for the department.

B. Responsibilities/Accountabilities

- Reviews and analyses applications for the registration of market participants and securities to assess compliance with the provisions of the securities legislation, guidelines, and policies;
- Advises and makes recommendations on applications for registration of market participants and securities;
- Maintains the integrity of the division's repository of registrant and securities information;
- Reviews, analyses, monitors and tracks financial statement submissions of market participants;
- Develops, undertakes and collaborates on research projects on, registration and disclosure matters to inform the decision making process of the division;
- Contributes to the development and creation of regulations, guidelines, and legislation aimed at facilitating the orderly growth, development and operation of the local securities market;
- Responds to requests from internal and external stakeholders for information and/or guidance on registration and disclosure matters related to market participants; and
- Performs other related duties as required.
