By Notice dated July 23, 2015 Guardian Group Trust Limited (the Trustee of the below mentioned Guardian Asset Management Series of Mutual Funds) convened a unitholder meeting for the purpose of changing the auditors of the Mutual Funds. A copy of such Notice is attached for ease of reference. Guardian Asset Management Series of Mutual Funds are as follows:

- CARBBEAN SERIES OF MUTUAL FUNDS The TTD Monthly Income Fund, The USD Monthly Income Fund, The Pan Caribbean Balanced Fund, Emerging Markets Bond Fund;
- THE GLOBAL FUND SOLUTION The Conservative Fund, Moderate Fund and Aggressive Fund;

Section 25 of Part XIV of the SEC issued "Guidelines on Collective Investment Schemes (July 2008)" states that a change in auditor of a Collective Investment Schemes ("CIS") also referred to as mutual funds is considered a material change and once such a change is made to a mutual fund, a supplementary prospectus must be filed with the Commission and a press release disclosing the material change published and filed with the Commission.

The meetings of the unitholders of the above mentioned Funds took place on September 8, 2015 and approved the proposed resolution to change the auditors from PricewaterhouseCoopers to Ernst and Young.
