Guardian Holdings Limited (GHL) has been notified that:

- The National Commercial Bank of Jamaica Limited (NCBJ) that NCBJ has agreed to purchase 29.9% stake in GHL.
- This acquisition will be achieved through a private sale of GHL shares held the International Finance Corporation and by companies owned by the Lok Jack and Ahamad families.
- Even though they will sell a portion of their shareholding to NCBJ the Lok Jack and Ahamad families will continue to hold a significant stake of approximately 22% of GHL.

The successful completion of this transaction is subject to regulatory approvals in both Trinidad and Tobago and Jamaica.
