3. DESCRIPTION OF MATERIAL CHANGE

Provide a description of the material change

In December 2019, GraceKennedy Financial Group Limited (GKFG), a wholly owned subsidiary of GraceKennedy Limited acquired a 15% interest in Key Insurance Company Limited, a company listed on the Junior Market of the Jamaica Stock Exchange. The price per share was J\$2.01 and the purchase price of J\$111,090,949.29 has been paid in full.

GRTG now intends to make a cash offer to purchase 100% of the issued share capital of Key at a price of J\$2.01 per share subject to the terms and conditions outlined in the Take-Over Bid Circular dated January 16, 2020. The Offer will open for acceptance by Key's shareholders at 9:00 am on January 27, 2020 and will close at 4:30 pm on Fabruary 17, 2020.

The Take-Over Bid Circular which sets out the details of the the Offer has been simultaneously delivered to the Board of Directors of Key, the Jamaica Stock Exchange, the Financial Services Commission, the Trinidad and Tobago Securities Exchange Commission and the Trinidad and Tobago Stock Exchange. It will be be sent to Key's shareholders in due course.
