As the regulator of the securities industry, the Trinidad and Tobago Securities and Exchange Commission ("TTSEC/Commission") is mandated in accordance with Section 6 (g) of the Securities Act Chapter 83:02, to educate and promote an understanding by the public of the securities industry and the benefits, risks and liabilities associated with investing in securities.

Since the inception of the Commission's Investor Education (IE) Programme in 2005, the TTSEC's IE initiatives have evolved and expanded to include both traditional means of engagement and those created through the advancement of digital technology. The theme focusses on '*The Importance of Financial Inclusion*' which has been identified by the Global Financial Inclusion Index 2023, as an emerging trend and speaks to the growing importance of financial education.

Among the activities planned by the TTSEC for National IE Month include: a public exhibition at Long Circular Mall, St James, on May 2nd 2024 from 10am to 4pm; collaboration with the Financial Literacy Secretariat, Tobago House of Assembly, to host an '*Investor Starter Forum*' on May 16th 2024 and a radio and social media public education series on investing that will run from May 1st -31st 2024.
