## **TTSEC Hosts 25<sup>th</sup> Anniversary National Tertiary Quiz Competition**

The Trinidad and Tobago Securities and Exchange Commission (TTSEC) is hosting its 25<sup>th</sup> Anniversary National Tertiary Quiz competition on the securities industry and financial literacy, centering on the theme, *'You Invest. We Protect. Everyone Benefits!'*. The quarter-final rounds which consisted of three rounds of competition was held on Wednesday September 21, 2022.

Throughout this round of competition, questions posed were in relation to the history of the TTSEC its legislative framework, market data, collaborations and investor education. A category of questions focused on financial literacy, was submitted by the Central Bank of Trinidad and Tobago, National Financial Literacy Programme (CBTT/NFLP).

Five (5) Tertiary Institutions are participating in this year's quiz competition. They are:

1. Arthur Lok Jack Global School of Business - UWI
2. Cipriani College of Labour and Co-operative Studies (CCLCS)
3. Council of Legal Education (Hugh Wooding Law School)
4. CTS College of Business and Computer Science Limited
5. UWI School of Business and Applied Studies Limited (Trading as ROYTEC)

These schools are vying for first place of the champion trophy, gold medals and \$15,000 to invest in the local securities market; and the second place of \$9,000 to invest in the local securities market along with silver medals courtesy the TTSEC. Student prizes were also part sponsored by the CBTT/NFLP in the form of electronic devices for semi-finalists and individual tokens for all participating students.

The quarterfinals saw five strong teams battling, with two tie breakers. It was an exciting three rounds of competition, but only four teams were able to advance to the semi-final round based on maximum scores. To see who will be moving on to the semi-final round, tune in to CNC3 from September 27<sup>th</sup> to 29<sup>th</sup> 2022 at 4:30pm and 5pm to catch the full broadcast of the quarterfinals.
