## Provide a description of the material change

NCB Financial Group Limited (NCBFG) has entered into a Share Purchase Agreement (SPA) with Cornerstone Financial Holdings Limited, a privately held company organised in Barbados, for the sale of 30.20% of the equity of Clarien Group Limited (Clarien Group). Clarien Group is domiciled in Bermuda and its subsidiary, Clarien Bank Limited, operates under a banking licence in Bermuda.

The completion of this transaction is subject to conditions, including the requisite regulatory approvals. Following the proposed sale, NCBFG will maintain a 19.90% equity interest in Clarien Group.
