Such interested parties are requested to make written submissions by **3:00 p.m. on Tuesday 7<sup>th</sup> January, 2020;**

**AND FURTHER TAKE NOTICE** that upon failure of any party to attend at the time and place of the Directions Hearing, the Directions Hearing may proceed in the absence of that party and such party is not entitled to any further notice of the proceeding.
