AGL's Offer opened on 17th June 2025 and remains valid for a period of Thirty-Five (35) days and expires on 21st July 2025.

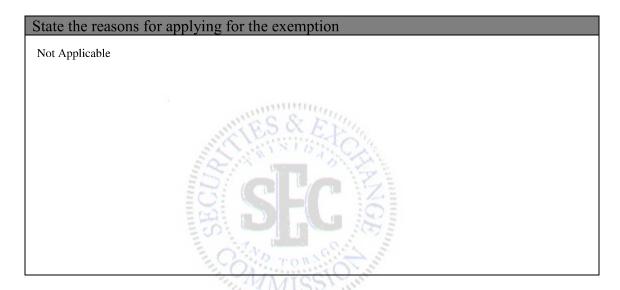
