3. DESCRIPTION OF MATERIAL CHANGE

Provide a description of the material change

Republic Financial Holdings advises that on 29th July, 2022 the Board of Directors approved the merger of 2 subsidiaries within the Republic Group, subject to all regulatory approvals, namely, Republic Bank (Cayman) Limited (RBKY) and Cayman National Bank (CNB).

CNB is a wholly owned subsidiary of Cayman National Corporation (CNC) and Republic Bank Trinidad & Tobago (Barbados) Limited (RBTTBL) owns 74.99% of CNC. RBTTBL also owns 100% of RBKY and RFHL owns 100% of RBTTBL.

RBKY's entire book of business will be transferred to CNB and upon the effective date of the merger, CNB will be the surviving entity, RBKY will be struck from the Registrar of Companies and will cease to be a subsidiary within the Republic Group of companies.

Although the transaction has been approved by RFHL's Board, it also requires approval from the several Boards of the other entities, involved in the transaction, in particular, RBTTBL and CNC. Furthermore, the regulators of those entities in the respective countries, namely Barbados & Cayman Islands are also to be advised after the Board approvals are given but before any publication anywhere is made. All meetings are carded for August and we shall advise when all meetings have been concluded.

Consequently, it is proposed that we publish within seven (7) days of all relevant Board approvals being given.
