The Trinidad and Tobago Securities and Exchange Commission ("the Commission") is responsible for ensuring that the securities industry operates in a fair, transparent and efficient manner in order to protect the rights of investors.

The Commission regulates the market by registering all securities issued to the public, all issuers of those securities, all market actors, i.e., brokers, dealers, traders, underwriters, securities companies and investment advisers; and all self-regulatory organizations.

#### HOW DOES REGISTERING WITH THE COMMISSION PROTECT INVESTORS?

Registration requires all issuers of securities and market actors ("registrants") to provide the Commission with pertinent information regarding the company, its directors and the securities being offered to the public or to investors. The Commission ensures that the information meets the requirements of the law and is available to the public.

Firms and individuals are registered by category - each registration category attracts different educational and experience requirements, and permits different activities. The Commission ensures that the companies are genuine entities with a registered office, headed by qualified professionals who possess the knowledge, skills and experience to conduct the class of business for which the companies are being registered.

#### WHAT ARE THE QUALIFICATIONS FOR **REGISTRATION?**

Registration will not be granted unless the Commission is satisfied that an applicant is fit and proper, meets the

requirement of the law with respect to capital and educational qualifications and discloses any information that may affect the conduct and integrity of his business. This information is also available for public viewing at the Commission.

However, the provision of information does not end after the initial registration. Registrants are required to continuously provide the Commission, as well as investors, with information inclusive of changes which may positively or negatively impact the performance of their business and the securities available to investors.

#### IS REGISTRATION AN ENDORSEMENT?

While we advise investors to deal only with issuers and market actors that are registered with the Commission, registration with the Commission is NOT an endorsement of the registrant or of any security. The Commission provides neither guarantee nor opinion on the performance of the product.

Always remember, even though you are dealing with someone who is registered with the Commission, you should evaluate the registrant and the securities being offered and if necessary, seek independent financial advice before making an investment decision.

The Commission has provided a listing of companies and individuals who are authorized and registered to sell securities as at March 31, 2011 as indicated on the following pages.

#### **DEFINITION OF TERMS**

### Broker/Dealer

An individual or firm acting as an intermediary between a buyer and a seller of securities, usually for a fee or a commission. When acting as a broker, a broker/dealer executes orders on behalf of his/her client. When acting as a dealer, a broker/dealer executes trades for his/her firm's own account

An individual or firm that advises clients on investment in, or the purchase or sale of securities on a professional basis.

#### Reporting Issuer

A corporation that has issued or proposes to issue securities to the public and is subject to the continuous disclosure requirements of the Commission.

#### Self-Regulatory Organization

A non-governmental organization that has the power to create and enforce industry regulations and standards. The priority is to protect investors through the establishment of rules that promote ethics and

#### Trader

An employee of a broker who executes buy and sell orders for the broker and its clients either on a stock exchange or the over-the-counter market.

#### **Underwriter**

One who arranges a new issue of securities and agrees to purchase any unsold securities thereby guaranteeing full subscription.

#### Securities Company

A securities company is a hybrid in that it is a company that can act as a Broker and/or Dealer and /or Investment Adviser and /or Underwriter.
