<p>RESUMPTION OF OPERATIONS</p> <p>Trinidad Cement Limited ("TCL" or "the Company") hereby advises that on May 8, 2020 the Company received the approval from the Government of Trinidad and Tobago to resume all of TCL's operations in Trinidad and Tobago. In accordance with this approval, TCL has resumed all of its operations. TCL further advises that the operations of its wholly owned subsidiary, Arawak Cement Company Limited has also resumed.</p> <p>As previously disclosed, in accordance with <i>The Public Health [2019 Novel Coronavirus (2019-nCoV)] (No.5) Regulations, 2020</i>, dated March 28, 2020, TCL had temporarily halted its operations, save and except activities related to the safe operation of the kiln and the port operations, and in accordance with certain orders addressing COVID-19 issued by the Government of Barbados, on even date, Arawak Cement Company Limited, a wholly owned subsidiary of TCL, had temporarily halted operations at its cement manufacturing facility located in Checker Hall, St. Lucy, Barbados.</p> <p>The health and safety of the Company's employees, contractors, customers, suppliers and all other stakeholders, continue to be of great importance to TCL. As such, the Company's operations, and those of Arawak Cement Company Limited shall be conducted in adherence with the strictest health and safety protocols.</p>
