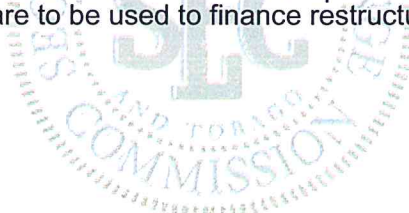

<p>On March 15th, 2022 Telecommunications Services of Trinidad and Tobago Limited (TSTT) entered into new credit arrangements whereby TSTT issued additional 8.30% Senior Secured Notes due 2029 in the amount of TT\$476,000,000.00 at par under and pursuant to an indenture dated October 18th, 2019 among TSTT, U.S. Bank Trust Company, National Association (formerly known as U.S. Bank National Association) and Republic Bank Limited. The net proceeds of the issue of the additional Senior Secured Notes are to be used to finance restructuring costs and to pay related fees and expenses.</p>
