The Board of Directors of the Trinidad and Tobago Mortgage Finance Company Limited (TTMF) advises that the Caribbean Information and Credit Rating Services (CariCRIS) has reaffirmed TTMF's "**high creditworthiness**". Specifically, TTMF has received credit rating "**CariAA-**" (Foreign and Local Currency Ratings) on its regional scale and "**ttAA-**" on the Trinidad and Tobago national scale). Caricris has also revised the outlook on the ratings from "**stable**" to "**negative**". The negative outlook is based on the expectation of CariCRIS that TTMF will experience weakened financial performance over the next 12-15 months due to the impact of the coronavirus (COVID-19) Pandemic. This Credit Rating was issued on September 29, 2020.
