History of the Matter:

On Friday 12th July, 2013, the date originally carded for TCL's AGM, the Honourable Mr. Justice Harris granted the injunction request put forward by the group of TCL's minority shareholders (collectively holding 5.68% of the company) which subsequently halted the AGM one hour before it was scheduled to begin. An appeal was immediately filed; however the injunction was upheld in the Port of Spain Court of Appeal on November 20th, 2013 by Justices of Appeal Soo Hon, Rajnauth-Lee and Narine. The matter is now before the Honourable Mr. Justice Hannays in the High Court for trial.
