Sagicor Financial Corporation - 06.01.15

Sagicor Financial Corporation has informed the Stock Exchange that following the recent lowering of the sovereign rating on Barbados to "B" from "BB-", Standard and Poor's (S&P) on December 30, 2014 lowered the rating on Sagicor Life to "BB-", from "BB+". The rating action on Sagicor is as a direct result of the rating action on Barbados, and the rating on Sagicor remains the maximum two notches above its Sovereign Barbados. At the same time, S&P lowered the rating on Sagicor Finance Ltd.'s US \$150 million, 10 year senior unsecured note to "B". Sagicor passed stress tests for both Barbados and Jamaica; and therefore S&P assigned a rating of "BB-", which is above the current rating of these two countries.
