Listed Company Information

Trinidad Cement Limited - 21.08.14

Trinidad Cement Limited (the Company) has informed the Stock Exchange that on Tuesday, August 19th, 2014, a Special (Compulsory) Meeting of Shareholders of the Company was held, at which over 80% of Shareholders were represented.

Prior to the Meeting, Mr. Andy Bhajan, Dr. Rollin Bertrand, Mr. Brain Young, Dr. Leonard Nurse, Mr. Carlos Hee Houng and Mr. Bevon Francis, submitted their resignations as Directors of the Company effective August 19th, 2014.

At the Meeting, Mr. Wilfred Espinet, Ms. Alison Lewis, Mr. Christopher Dehring, Mr. Michael Glenn Hamel-Smith, Mr. Francisco Aguilera, Mr. Carlos Alberto Palero and Mr. Nigel Edwards were unanimously elected Directors of the Company, until the conclusion of the next Annual Meeting of the Company, at which time they will be eligible for re-election by the shareholders. The newly elected Directors have joined Mr. Alejandro Ramirez, Mr. Jean Michel Allard and Mr. Wayne Yip Choy to form the Board of Directors of the Company.

Mr. Wilfred Espinet and Mr. Francisco Aguilera were appointed by the Board as Chairman and Deputy Chairman respectively. The Board took the decision to suspend, with immediate effect, Dr. Rollin Bertrand as Group Chief Executive Officer (CEO) and from all Committee and Executive positions within the Group. The Board also appointed Mr. Alejandro Ramirez as acting Group CEO.

Unilever Caribbean Limited – 20.08.14

Unilever Caribbean Limited (UCL) has informed the Stock Exchange that on July 31st, 2014, Mr. Livio Vicco resigned as a Director of UCL. His vacancy on the Board was filled by Mr. Emerson Inacio effective August 01st, 2014.

First Citizens Bank Limited – 19.08.14

First Citizens Bank Limited has informed the Stock Exchange that they have successfully issued a TT\$500 million bond and generated an increase in its profits for nine months to June 2014.

The bonds are divided into two categories, a 7 year \$400 million issue at 3.10% and a 10 year \$100 million bond at 3.25% interest rate. The bonds were arranged by First Citizens Investment Services on behalf of the Bank. Funds from the bond issue will go towards partially retiring \$1 billion in bonds previously issued by First Citizens.

For the first nine months of the Bank's financial year, June 2014, First Citizens recorded an after tax profit of \$477.6 million, a \$13.5 million increase over the corresponding period of last year. "The Group's 9 month performance was particularly noteworthy in light of current market conditions which continue to be marked by high liquidity, reduced credit demand and low interest rates, "states the Chairman of First Citizens, Anthony Smart.

Trinidad Cement Limited – 19.08.14

Trinidad Cement Limited (TCL) has informed the Stock Exchange that on Monday 18th August, 2014, TCL's Application for an Interlocutory Injunction to restrain Mr. Kamal Ali from holding and/or otherwise proceeding with the Special (Compulsory) Meeting of Shareholders, which was fixed for 19th August, 2014 at 5:00 p.m., was dismissed by Madame Justice Kangaloo. TCL lodged an Appeal with the Court of Appeal, which was scheduled to be heard on Tuesday 19th August, 2014, prior to the requisitioned Special (Compulsory) Meeting.
