Listed Company Information

GraceKennedy Limited - 23.12.14

GraceKennedy Limited has informed the Stock Exchange that the company repurchased 47,102 stock units between the period December 09th to 10th, 2014 under the 'GraceKennedy Repurchase Programme'.

Sagicor Financial Corporation – 22.12.14

Sagicor Financial Corporation has informed the Stock Exchange that on December 11th, 2014 a Director sold 50,000 preference shares.

Trinidad Cement Limited - 22.12.14

Trinidad Cement Limited (TCL) has informed the Stock Exchange that the Company signed a Memorandum of Agreement ("MOA") with the Oilfield Workers Trade Union (OWTU) in relation to the Order of the Industrial Court in Trade Disputes 290-294 of 2012, the related Court of Appeal matter (Civil Appeal No. 2014 - P225 - Trade Dispute Nos. GSD TD – 209-294 of 2012), and all outstanding items for 2012-2014. The MOA sets out the terms under which all these matters will be settled and also covers the local TCL subsidiaries represented by the OWTU.

Republic Bank Limited – 18.12.14

Republic Bank Limited (RBL) has informed the Stock Exchange that The Supreme Court in Ghana by unanimous decision on December 17th, 2014, ruled in favour of RBL in an application, to quash a ruling of the Accra High Court. The High Court Ruling prevented the Bank from proceeding with a mandatory offer to all shareholders of the HFC Bank (Ghana) Limited under the 'Takeover Code' of the Securities and Exchange Commission (SEC).

A five-member panel of Justices dismissed the suit which was initiated by HFC Bank against Republic Bank and the SEC. This was in an attempt to prevent RBL from proceeding with a mandatory offer to all shareholders of HFC Bank after RBL had acquired more than 30% of the shareholding of HFC Bank.

GraceKennedy Limited – 17.12.14

GraceKennedy Limited has informed the Stock Exchange that the company repurchased 108,231 stock units on December 03^{rd} , 2014 under the 'GraceKennedy Repurchase Programme'.

FirstCaribbean International Bank Limited – 12.12.14

FirstCaribbean International Bank Limited (FCI) advised the Stock Exchange of the appointments of Mr. David Arnold and Mr. Brian Clarke as Directors of FCI, to fill the casual vacancies arising from the resignation of Mr. Richard Nesbitt and the passing of Mr. Michael Mansoor, effective December 11th, 2014, subject to regulatory approval.

Additionally, FCI has advised that Mr. Kevin Glass, a Director of FCI has resigned from the Board of FCI effective December 12th, 2014.
